- Presentation of the Report of the financial statements:
The balance in the bank account as at 31st December 2018 was \$41,136.71 and the balance in the Paypal Account was \$617.30.
The Total Income for the year was \$16,368.35 and the Total Expenses were \$14,323.84 leaving a small profit of \$2,044.51.

- General Business
 - Webpage: Most of the requested updates have been completed. There is a possible issue if a guest teacher is added they become a member, we need to clarify further with testing to ensure they are not saved as a financial member. There may be an additional payment required for extra plugins. Further testing will be done asap by the Committee and any issues discussed via email.
 - Bank refund – Still in progress
 - Bank signatures – The bank hasn't confirmed back with KF, she will contact them to confirm status
 - Membership drive. We have had a good response so far with 32 renewals to date. DK is to contact Reps asking them to assist with the Membership drive. Newsletter will be sent shortly promoting membership.
 - Member categories. Decided not to add Associate Membership category at this stage.
 - Policy procedures update. BK updated - In progress, is aiming for completion by end February.

- Insurance – No incentives offered by Insurance Companies for our recommendation to Members. Decided to add Insurance House as a default recommendation on our Website.
- Sponsorship. A request was made for an Event sponsorship by Tej Bhagti Kaur to cover the cost of Air Fares for Guru Devi. The Committee are not able to sponsor this event, our main sponsorship areas are for Student Teacher trainings and agreed programs, eg Outreach. It was noted that Tej Bhagti Kaur is not a member of KYTANZ.
- Kathy Heathcote has requested another 2 years of free membership as compensation for her information not being accessible on the KYTANZ website recently. Marsha Tauber also requested 1 year free as her compensation. The original situation was caused by a Paypal plug-in causing issues with the searching capabilities on the website. It also meant that a number of Member's information could not be found for approx 14 months. This was subsequently rectified by Balwant Singh and manual updates to Member Information by Balwant Kaur. The Committee agreed to give all Members 1 year free Membership and 2 years of IKYTA membership as compensation to its members. The Committee felt this was fair and that if exceptions were made then all Members would expect the same consideration. RG to write to Kathy and Marsha.
